Approval Requirements

- 1. All dogs must be registered, microchipped and desexed as required under the Dog and Cat Management Act 1995, prior to a permit being issued.
- 2. Premises must be suitable for housing the dogs including size of yard and adequate fencing.
- **3.** Applications may be subject to an assessment process including history of dog ownership and possible consultation with immediate neighbours.
- **4.** The property where the dogs are to be housed will be subject to inspections by Councils Authorised Officers by appointment.
- 5. Fees and Charges Application fee per Council fees and charges schedule applies. Permit fee must be paid prior to permit being assessed.

NOTES TO APPLICANT

Should your permit be approved, the following conditions will apply:

- 1. Council may inspect the property at any time to ensure compliance with conditions of approval (if any).
- 2. A permit is valid for dogs as listed on the application and subsequently the permit. Should a dog leave the property Council must be notified within 14 days as required by the Dog and Cat Management Act 1995. If the number of dogs no longer exceeds the permitted number of dogs allowed then the permit will be cancelled.
- 3. In the event of the death or rehoming of a dog you are not entitled to obtain another dog without first applying for a new permit.
- 4. Should Council receive any substantiated complaints relating to the dogs kept on the property for which the permit is issued, Council may revoke the permit at any time. Complaints received will be investigated and may include (but are not limited to) the following:
 - i. Barking dogs or other noise
 - ii. Odour created by the dogs
 - iii. Dog/s leaving the property unattended and/or Wandering at Large
 - iv. Dogs/s attacking or harassing another animal or human
 - v. The number of dogs on the property exceed the number of dogs approved in writing by the Council
- 5. Permits are not transferable from property to property as the basis for approving a permit to keep more than two dogs relies (in part) on the property being suitable for this purpose. If you move to another property you will need to apply for a new permit.
- 6. Any breach of the conditions of a permit may result in the cancellation of the permit, an order to remove dogs from the property and may attract an explation or fine.
- 7. Additional conditions may be applied at Council's discretion.
